GENERAL ASSEMBLY & QUADRENNIAL ELECTION REGISTRATON

All Eligible Delegates of Michigan Southwest Third Jurisdiction will be able to log into your ARC account and register for the General Assembly beginning Monday, October 17, 2022. Eligible Delegates may continue registering until Friday, November 4, 2022 (11:59 p.m. CST). Payment of \$22.50 by credit or debit card is required.

To register please follow these instructions:

- 1. Log onto COGIC ARC at www.cogicarc.com
- Access your ARC account using the email listed on your account and password you established. If you cannot
 access your ARC account, DO NOT attempt to establish a new account. Contact the Jurisdictional Secretary for
 an email or password reset.
- 3. Click on the purple "General Assembly" icon.
- 4. Click on the "GA Payment and Registration" icon.
- 5. Enter all of the information requested and submit your payment.
- 6. Click "Return to General Assembly Delegate Information" to see your Certificate of Election. Print the certificate if you will be attending in-person.
- 7. If attending virtually:
 - a. The day before the General Assembly, Sunday, November 13, 2022 you will receive an Access Code Email.
 - b. The Access Code is exclusive to each delegate and SHOULD NOT BE SHARED.
- 8. On Monday, November 14, 2022 the General Assembly will convene 8a.m. 8p.m.
- 9. If attending in-person
 - a. Pick up your General Assembly Badge Monday, November 7 Sunday, November 13 Renasant Convent Center Lower Level Room 112
 - b. Bring your:
 - 1. Blue and Gold National Credential Card
 - 2. Certificate of Election
 - c. You will receive:

 - 3. Programmed Smart Card
 - 4. In-person Delegate Election Support Guide
